## AUDIT MEMORANDUM ON THE WORKING OF THE KHUMAN YANGBI KHONGPAK MAKHA PADDY-CUM-PISC. COOP. SO LET FOR THE YEARS 2020-2021 TO 2022-2023

I have audited the accounts of the KHUMAN YANGBI KHONGPAK MAKHA PADDY-CUM-PISC: COC SOCIETY LTD. for the years 2020-2021 to 2022-2023 and chalked out the following observations of

- Membership and Pald-up Share: The Society has 79 members at the end of 31-03-2023 and total paid 1. up share capital of the society at the end of 31st March, 2023 is Rs. 6,57,000/- only subscribed by the 54 members of the Society.
- Maintenance of Books and Records: The Society have maintained some books such as Cash Book, 2. Stock Register, Resolution Book along with vouchers. But it is suggested that all the required books i.e. Purchase Day Book, Sales Day Book, General Ledger etc. should also be maintained properly and systematically.
- Management: The management of the Society was vested in a Board of Directors consisting of 7 3. (seven) Members which were by the Special General Body Meeting held on 20-06-2019 vide Resolution No. 1 for a term of 5 (five) years. They are:
  - Wahengbam Kunjeshwor Singh 1.
  - Gurumayum Iboyaima Sharma 2.
  - Wangjam Sunil Singh 3.
  - Yumnam Brojen Singh 4.
  - Dr. Mayengbam Biren Singh 5.
  - Khaidem Gokulchandra Singh 6.
  - Helsnam Ibungo Singh 7.



Further, vide Resolution No. 1 of the Managing Committee Meeting held on 07-07-2019 Office Bearers of the Society was elected for a term of 5 (five) years. They are:

- Working: The main working of the Society is related with fishery and its allied activities. During the year 2022-2023, the Society could sell fishes for a sum of Rs. 5,30,000/- when the society has spend a sum of Rs. 4,71,000/- in trade. During the year, the Society could earn a net profit amount to Rs. 41,359/-.
- Classification: As per audit classification, the Society is placed at "C" class. 5.
- Audit Fee: Audit fee for the auditing years upto 2022-2023 comes to Rs. 5,128/- only. 6.
